



Weeks Bay Plantation - Food Truck Agreement

May 5 - June 16

If accepted, this document is a legally binding contract between the vendor and Weeks Bay Plantation (WBP). This document outlines the responsibilities of WBP and the vendor. All guidelines must be followed. Non-compliance will result in breach of contract.

Weeks Bay Plantation will provide an designed area to set up. **(space is designated by Weeks Bay Plantation)**

Vendors: (by signing this agreement, the vendor accepts the following responsibilities)

- Fees, Licenses and Permits- vendors shall be responsible for obtaining and paying for any and all fees, licenses and permits required by any and all governmental agencies with jurisdiction for the event.
- Vendor Set-Up - vendor will supply and is responsible for all equipment needed for their operation (beyond the above provided by WBP). Vendor is responsible for complying with any and all regulations for fire, health and safety and shall comply with any and all requirements by governmental entities having jurisdiction over their operations. Vendor will be responsible to contain and remove all waste generated by vendor preparation or breakdown. This doesn't include guests' waste.
- Site Maintenance - vendor shall be solely responsible for all damages caused by the vendor or vendor's employees to any buildings, grounds, persons or personal property and shall indemnify WBP from all such damages, claims, injury or defense costs.

- Taxes & Permits - vendor is responsible for compliance with all state and local laws, regulations and fees, including but not limited to, City and County Departments of Health and Revenue.
- **Weeks Bay Plantation Request of our vendors-** We are asking for your assistance in promoting the Harvest Nights series through the social media outlets you currently use for your business. Example: We ask you to please go to our Facebook page and “like” us; go to our events and check “going” and then “share” the event on your timeline. Please consider “boosting” each date for even \$5 in lieu of paying to be a part of the events at Weeks Bay Plantation.
